DETAILED VACANCY CIRCULAR

Applications are invited from the eligible officers for filling up the post of **Technical Officer**, a General Central Service, Group 'A' Gazetted post in Level-10 of the Pay Matrix in the Directorate of Sugar & Vegetable Oils - an attached office of the Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution, by Deputation (including short-term contract).
